Background


Thai Danish Dairy Farm (TDDF) was a technical cooperation project between the Thai and Danish Governments. The TDDF was initiated during His Majesty the King Bhumipol Adulyadej of Thailand's state visit to Denmark in 1960. The King was interested in dairy farming and the Danish Agricultural Organization presented this project. On 16th January 1962, the farm was inaugurated by Their Majesties the late King Frederik IX of Denmark and King Bhumibol Adulyadej of Thailand. On October 19, 1971 the TDDF was transferred to the Thai government and, with His Majesty the King Bhumibol's royal grace, was granted the status of a state enterprise under the Ministry of Agriculture and Co-Operatives in the royal decree. It was then given a new name of "The Dairy Farming Promotion Organization of Thailand (D.P.O.)".



D.P.O. serves as a mechanism to solve the oversupply of raw milk with a production capacity of over 585 tons/day.


D.P.O. acts as secretary committee of The School milk program committee and manages the School Milk budget over 13,000 million Baht/year and more than 7 million students benefited.
